- The details regarding the venue, date and time of Spot Admission shall be clearly notified in the website of the College.
- The list of candidates participated in the Spot Admission should be clearly monitored and attendance sheets shall be maintained and forwarded to ASC soon after the completion of Spot Admission.
- The College is at liberty to contact the ASC for any instructions/clarification for conducting the Spot Admission.

The Spot Admission should be transparent, merit based, non-exploitative. If any irregularities/ complaints are received against the process of Spot Admission and found to be proved, the Spot Admission shall be cancelled without any further notice. The closing date of admission should be as per the notification issued by the KUHS and Government of Kerala.
